Rev Track uses encrypted software to protect credit and debit card transactions, guaranteeing safety for parents and efficiency for the school. Hamilton explained a few of the many benefits of using the automated system by adding, "The less the school can work with cash, the better. [This system] makes it more expedient for everyone involved."

However, despite Hamilton's views, some students who use the new Rev Track system regularly seem to disagree. Senior, Jared Bruns, believes, "If you're going to pay in cash anyway does it really matter? [The system] makes things more complicated than it has to be." Other students, like junior Charmaine Balisalisa, have feelings of indifference towards the new system and simply reply, "I don't mind it."

Although the response to this new system varies considerably, the fact that it has impacted LHS remains certain. At the end of the school year, the District plans to evaluate customer and school satisfaction with the new system and decide where changes must be implemented. However, Hamilton appeared to have a great deal of confidence in the new system when he said, "I honestly only see this going further. I only see it moving forward."
