## Question #1 - Chapters 1-2

To what extent did social issues such as abortion, gay rights, and affirmative action serve as the basis for political conflict within and around the Supreme Court in the 1980's?

#### Question #2 - Chapters 3-4

The nominations of both Kennedy and Souter were intended to overturn the liberal decisions of the Warren Court. Which of these two nominations represent the greatest miscalculation by presidential administration? Explain and support your claim with three examples.

#### Question #3 - Chapters 5-6

Justice Thomas was labeled "The youngest, cruelest justice," while Kennedy was described as "having a change of heart." Are either of these appropriate labels for these conservative justices?

### Question #4 - Chapters 7-8

On page 181, the author compares the justices and judicial philosophy to hedgehog and foxes. Which sort of justice do you prefer? Explain your response citing at least three cases discussed in the book to support your answer.
